Wolfram Körner

Grab Wolfram Körner französischer Friedhof Berlin

Hier kommt der 2. Teil der Exlibris aus der Veröffentlichung ‚Das Mädchen und der Tod‘, dass 2004 im Verlag Exlibristen, Frederikshavn 2004 veröffentlicht wurde.

Kurzbiographie: Geboren 20.11.1920 in Chemnitz, gestorben 22.06.2019 in Berlin. Körner arbeitete als Chirurg und Tropenarzt im Regierungskrankenhaus der DDR. Seine Kontakte nutzte er beispielsweise dazu, um Sammler und Bibliophile vor der Plünderung durch Schalck-Golodkowskis Devisenbeschaffer zu schützen. In seiner Kaderakte soll gestanden haben: „Der Genosse ist politisch unzuverlässig, aber man kann fachlich nicht auf ihn verzichten.“ Körner war Gründungsmitglied und von 1981 bis 1994 Vorsitzender der Bibliophilen-Vereinigung Pirckheimer-Gesellschaft. Die Pirckheimer-Gesellschaft e.V. wurde von ihm erfolgreich durch die Wende- und Nachwendewirren geführt.

Here comes the 2nd part of the bookplate from the publication ‘The Girl and Death’, which was published in 2004 by Exlibristen, Frederikshavn.

Short biography: Born November 20, 1920 in Chemnitz, died June 22, 2019 in Berlin. Körner worked as a surgeon and tropical doctor in the GDR government hospital. He used his contacts, for example, to protect collectors and bibliophiles from being plundered by Schalck-

Golodkowski's foreign currency procurers. His personnel file allegedly stated: "The comrade is politically unreliable, but professionally, he is indispensable." Körner was a founding member and chairman of the Pirckheimer Society, a bibliophile association, from 1981 to 1994. He successfully led the Pirckheimer Society through the turmoil of the fall of communism and the post-reunification period.

Courte biographie : Né le 20 novembre 1920 à Chemnitz, décédé le 22 juin 2019 à Berlin. Körner a travaillé comme chirurgien et médecin tropical à l'hôpital public de la RDA. Il a utilisé ses contacts, par exemple, pour protéger les collectionneurs et les bibliophiles du pillage des fournisseurs de devises étrangères de Schalck-Golodkowski. Son dossier de cadre aurait déclaré : « Le camarade n'est pas fiable politiquement, mais professionnellement, nous ne pouvons pas nous passer de lui. » Körner a été membre fondateur et président de l'association bibliophile Pirckheimer Society de 1981 à 1994. Il a dirigé avec succès la Pirckheimer Society à travers les troubles de la chute du communisme et de la période post-réunification.

AIE wishes Happy Easter

Good morning everyone.

The days are flying by. There is so much to do and so little time.

We had our second board meeting earlier this week. I will publish the minutes [in the usual place](#) as soon as they are ready. In the meantime, I can tell you about the main issues discussed.

The first news is that Antonella Mensi, former President of the AIE, has resigned from the Board of Directors of our Association. As required by our statutes, the post will remain vacant until a member is found who is willing to step in.

As I wrote last time, I wanted to close the postal account to save costs, but the first member to renew her membership did so by postal order. So we planned to keep it for another year. When the time comes, I will let you know how to renew your subscription and put the postal option on the back burner.

Speaking of subscriptions. I still do not have access to the two social bank accounts. There is no need for you to renew now, although some have already done so spontaneously and others are asking me how to renew because they cannot wait. Thank you for your enthusiasm, which I must say is contagious and encourages me. There is no need to pay now as I have no way of accessing the accounts and cannot track the memberships.

Back to the subject of quotas. We chose to publish on the Substack platform because it takes away a lot of our worries at a relatively low cost. I could list the features that brought us here:

- The site is free as long as the AIE does not charge for subscriptions. I came to the presidency with a social archive of forty-three addresses. I am sending this message to nearly four hundred addresses free of charge. The articles remain available to all visitors without any form of subscription. Unlike other platforms, such as Facebook or Instagram, where you have to be a member to use the content;
- anyone who comes across this site can subscribe to the directory and receive the mailings. On this platform, the AIE is easier to find and the management of addresses is much easier for us President and Board members;
- the site complies with privacy regulations. The AIE is too small and poor to afford a consultant to keep a home-made site up to date. In the highlighted paragraph below, I publish a summary of the GDPR requirements for websites;
- *Substack* will automatically manage the collection of subscriptions and the sending of reminders to members when the subscription is about to expire. I cannot activate this feature until I have access to the bank account. Let's all be patient;
- in setting the new membership fee, the Board decided to raise it slightly, from 40.00 to 45.00 euros, and to leave the fee for supporting members unchanged at 80.00 euros, on the understanding that donations of higher amounts are welcome and possible. And here is the unexpected: when I later went to set the amounts of the contributions we will collect through Substack, I found out that the minimum amount

managed by the platform is 50.00 Euros. I take responsibility and apologise for the inconsistency. Those who pay by bank transfer or paying-in slip pay 45.00 euros, those who subscribe via the website pay 50.00 euros. Next year we will increase the fee to 50.00 euros and resolve this discrepancy. **I want to make it clear that there is only one fee** and that it is to be paid **once, either** by bank transfer **or** by credit card via Substack. I will write to you again when registration is open.

The GDPR regulations for websites cover all the necessary requirements for anyone processing personal data through a website. The GDPR (General Data Protection Regulation) came into force in May 2018 and imposes a high level of protection for users' personal data, with two main principles: control of data by the data subject and ensuring maximum security in processing by the data controller.

Key GDPR requirements for websites

- Compliant privacy policy: the website must provide a clear and comprehensive policy explaining what personal data is collected, for what purposes, how it is processed, stored and protected, and whether it is shared with third parties.
- It must also explicitly refer to the GDPR Explicit consent: before collecting personal data, including via cookies, the site must obtain the user's explicit and informed consent, specifying the purpose of the processing
- Cookies and tracking: the site must comply with the updated guidelines on cookies, providing a clear banner and the ability to accept or reject unnecessary cookies.
- Processing Register: The site owner must maintain a register documenting all data processing activities, including information on the owner, purposes, categories of data, recipients and international transfers, if any.
- Appropriate technical and organisational measures must be taken to protect personal data against unauthorised access, loss or unlawful disclosure.
- Appointment of a Data Protection Officer (DPO): if a DPO is appointed, the site must identify the DPO and his or her contact details in the privacy policy.
- Breach management: in the event of a data breach, the owner must notify serious breaches to the data protection authority and, where appropriate, to affected users within 72 hours

Sorry if that's not enough.

About our magazine, *L'Ex Libris Italiano (ELI)*. The Board of Directors has authorised me to register the title and look for a responsible editor-in-chief. For our foreign friends, who read us in Italian or read us here in the English translation of this missive, the following will be incomprehensible. To summarise: any newspaper published in Italy must have a registered masthead/nameplate and have an editor-in-chief who is a registered journalist with the Ordine dei Giornalisti. If this is not done, the crime of clandestine printing is committed. *This only happens in Italy*. Until the publication of the last issue, our ELI escaped any detection or attention. However, I would not want to be the President who goes down in history for something like this. The amounts needed to fulfil this obligation are moderate and have been approved by the CD. I have also found the responsible editor-in-chief, who will sign the paper. The editorial direction will remain with me.

In the next few weeks, I will meet a good friend of the bookplates, who has privileged relations with a layout studio and a printing house, and I will ask him for some quotes. I will let you know.
